#### Ester (Day 30)

Praise God for His continuous work among those who don't have the His Word in a language they understand! I'm currently working on a 'sensitive Scripture app'. It's such a joy to see the meticulous work of the translators in every detail of the translation and that this is faithfully reproduced in the digital version of the translation. E.g. in relation to the spelling of words (non-Roman/Latin characters): this will be the first time that some of them are seeing the name of their language written down. Let us trust the Holy Spirit to use His Word towards the repentance and faith of this people group. Pray for the new audio recording to accompany the text. Currently they only have audio for the books of Genesis and Luke. In the next week or two, the translators are expecting to add the book of Ephesians (after rigorous consultant-checking) to Genesis, Matthew, Mark, Luke, John, Acts, 1 Co, Philippians, Philemon, James, 1 Peter and 2 Peter.

### Bill & Angela (Day 16)

Please pray for a 13-year-old boy in our church who is starting to associate with the wrong types of kids at school. We perceive he is being tempted both sexually and by drugs and needs help to resist and grow in his walk with Jesus. On Friday our church will be starting an outreach to needy families through a kid's club. The club is designed for 5–10 year-olds after school on Fridays. We will feed them a substantial lunch followed by games and gospel lessons. We pray it will be a safe place for them to learn about Jesus and receive love. Our area and the capital city of Bogota is experiencing a major drought and water is being rationed. Please pray for rain.

Please pray for B. M., an Albanian lady living in an abusive situation in Fondi, Patrizia may be accompanying her to Rome for a medical visit next Saturday. B.M. has already been once to our home group meeting together with us. Please also pray that the Italian lessons to Indian women in a different location but still in Fondi, would resume.

We are getting into our normal weekly routine again now after the Easter school holidays have finished here. We were blessed to be able to have a week in a holiday apartment near Lake Constance. This brought a lot of refreshment to the family, as we have had a lot of sickness recently and we all really enjoy being close to water. In OJC we are preparing for a change of leadership, with the new leader taking over at the end of this month.

## Phil & Jill (Day 25)

We returned to NZ just over a week ago, but Phil went back to PNG again on Saturday. The government is finally sending a team to the College to assess our accreditation status, and Phil needs to be there for that. He will be there for two weeks. We are loving connecting again with family and grandkids. Praise God our house and garden are all in good order after ten weeks away. Pray for Phil and his involvement with the accreditation team. It feels like David against the giant. Psalm 46:10 "Be still and know that I am God" has been of huge encouragement to us. Pray that God would give the College favour with the review team.
