- 1. Growing churches emphasise mission and evangelism
- 2. Renewed churches emphasise the Holy Spirit and renewal
- 3. Spiritual churches emphasise prayer and community
- 4. Multiplying churches emphasise intentional church planting
- 5. Confident churches emphasise biblical power and authority
- 6. Effective churches emphasise local leadership

- 7. Inspiring churches emphasise the "Priesthood of all Believers"
- 8. Prophetic churches emphasise justice and human dignity
- Expanding churches emphasise simple, cell, and house models
- 10. Reproducing churches emphasise *churches planting churches*
- 11. Healthy churches emphasise rapid reproduction
- 12. Impacting churches emphasise whole-of-life faith and mission
- 13. Maturing churches emphasise contextual theology, faith and mission

PRACTICES: WHAT CAN WE DO?

10 practices we discover from the global church:

- 1. REIMAGINE CHURCH: THE FIRST PRACTICE: Reimagine the church as the new humanity in Jesus Christ.
- 2. RENEW LAMENT: THE SECOND PRACTICE: Renew our ability to lament together.
- **3. REPENT TOGETHER: THE THIRD PRACTICE:** Repent of white cultural captivity, and racial and gender injustice, and of our complicity.

PRACTICES: WHAT CAN WE DO?

- **4. RELINQUISH POWER: THE FOURTH PRACTICE:** Relinquish (give up) our own righteousness, status, privilege, selfish ambition, self-interests, vain conceit, personal gain, and power.
- **5. RESTORE JUSTICE: THE FIFTH PRACTICE:** Restore justice to those who have been denied justice.
- **6. RELISH DIVERSITY: THE SIXTH PRACTICE:** Relish diversity (choosing to be a people of every nation, tribe, people, and tongue), while cultivating unity in diversity.
- **7. REINFORCE AGENCY: THE SEVENTH PRACTICE:** Reinforce agency, which is people's ability to make free, independent, and unfettered actions and choices.

PRACTICES: WHAT CAN WE DO?

8. RECONCILE RELATIONSHIPS: THE EIGHTH PRACTICE:

Reconcile through repentance, forgiveness, justice, partnership, and relationship.

9. RECOVER LIFE TOGETHER: THE NINTH PRACTICE: Recover life together as a transformed community that lives out the vision of the Sermon on the Mount.

10. REVITALIZE CHURCH AND MISSION: THE TENTH PRACTICE:

Revitalize church and mission through new, life-giving, transforming practices.


